

RECEPTIONS

Welcome Reception is for attendees, speakers, and industry partners to attend. Thursday Welcome Reception will be held on 12/5/24 from 6:30 PM - 8:30 PM on the Event Lawn at The Playa Largo.

No outside events are to be scheduled prior to 8:00 PM on Thursday and prior to 6:30 PM on Friday.

DUE DATE: All exhibitor contracts are due no later than November 1, 2024. Exhibit space is limited and on a first come first served basis, early submission of the exhibitor application with payment is highly recommended to secure your space.

LIABILITY: Exhibitors are responsible for submitting an executed release of liability for themselves and/or its third-party representatives in charge of providing installation and dismantling services. If the Exhibitor fails to deliver the release, the Exhibitors will be prohibited from utilizing the exhibition premises. The release must include the following language: "To the fullest extent legally permissible, Exhibitor agrees: (i) it shall be fully responsible to pay for any and all damage to property owned by Hotel, or their affiliates or and of their respective owners or managers that results from any act or omission of Exhibitor, (ii) to defend, indemnify and hold harmless, Hotel and their respective owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damages or charges resulting from Exhibitor's use of the property; and (iii) its liability shall include all losses, costs, damages, or expenses arising from, out of, or by reason of an accident or bodily injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees, and business invitees."

EXHIBITOR LOSS AND DAMAGE HOLD HARMLESS:

Exhibitor hereby assumes entire responsibility and hereby agrees to protect, defend, indemnify and save Florida Society of Dermatology PAs (FSDPA), Gateway Consulting & Management, Playa Largo Resort, its owners, its operator, and each of their respective parent companies, subsidiaries, affiliates, employees, officers, directors, and agents harmless against all claims, losses or damages to persons or property, governmental charges or fines and attorney's fees arising out of or caused by its installation, removal, maintenance, occupancy or use of the exhibition premises or a part thereof, excluding any such liability caused by the sole gross negligence of FSDPA, the Hotel, its employees and agents.

INSURANCE: Exhibitor shall obtain and keep in force during the term of the installation and use of the exhibit premises, policies of Comprehensive General Liability Insurance and Contractual Liability Insurance, insuring and specifically referring to the Contractual liability set forth in this Exhibit Agreement, in an amount not less than \$2,000,000 Combined Single Limit for personal injury and property damage. Playa Largo Resort, its owners, and its operator shall be included in such policies as additional named insurers. In addition, Exhibitor acknowledges that neither, FSDPA, Gateway Consulting & Management, Playa Largo Resort, its owners, nor its operators maintain insurance covering the exhibitor's property and that it is the sole responsibility of Exhibitor to obtain business interruption and property damage insurance insuring any losses by Exhibitor.

SECURITY: The Hotel does not provide security. Each exhibitor must make provisions for safeguarding goods, materials, equipment, and display at all times. Doors will NOT be locked during scheduled meeting times.

LATE REGISTRATION FEE: Exhibit space requested after October 1, 2024, will be at a fee of \$5,500 per table and based on space availability.

PAYMENT: Full payment of all sponsorship fees, exhibit space fees, and additional fees, if applicable, must be submitted with the signed application. No space will be held without full payment. Payment will incur a late fee after November 1, 2024, of \$250 per 30 days payment is late.

CANCELLATION: No refunds will be issued for exhibit space cancellations or no-shows.

CONDUCT: Zero tolerance for unprofessional behavior, sexual harassment, bullying, and/or any disruptive behavior will be strictly enforced at this event. By registering for sponsorship and/or exhibit space your business and its representatives pledge to conduct themselves accordingly and agree to FSDPA's zero tolerance policy.
